Vanmali Srajan pith established to commemorate the contribution of Late luminary Educationalist, most reverend writer, poet, novelist and great story teller of Hindi, who remained the folk art, culture and epitomize the wisdom of yore in his works. The Vanmali Srajan Pith today patronizes the new generation writers, artists and creative thinkers from the Nimar Region and takes them to national and international forum. Setting up of the Harda Chapter of Pith would aid to purpose tourism and provide opportunities to young and budding talents in arts, literature and culture.
